#### **Course Description**

Microeconomic theory applied to pricing of products by seller having different market structures such as competition, imperfect competition, monopoly, public utility regulation or government pricing.

The book provides covers technical portions of the course and fill in gaps in your notes. The book is on the advance side and goes beyond the expectations for our class.

#### **Course Requirements and Assignments**

The exams will focus on material covered since the previous exam and are worth 15% each. The final exam is on **December 14 between 12:15 and 2:30pm.** The final exam is comprehensive and worth 20%.
- There will be about 25 in class quizzes and activities. Only the 15 highest scores will count toward your final grade. The scores after the 15<sup>th</sup> quiz will be extra credit for a potential max of 3 points added to your overall final grade. **No makeup quizzes.**
- Students will make a five-minute presentation in class. The presentation will discuss aspects of the course material regarding a firm of the student's choice. Estimated dates: 12/5 and 12/10
- There will be three homework assignments. The assignments will be due a week before each of the exams: 9/12, 10/17, and 12/5. I will drop the lowest score out of the three.
