University through service to the Academic Senate through much of her career serving as senator (2005-2012), member of Professional Standards Committee, member of Faculty Diversity/Affirmative Action Committee:

Whereas, Dr. Merdinger has served as Associate Dean of Faculty Affairs from 2001-

2004, and as Interim AVP for Faculty Affairs from 2004-2005, and AVP for

Faculty Affairs from 2005-2012; and

Whereas, Dr. Merdinger has provided thoughtful advice, consultation, and

interpretation of the complex Retention, Tenure, and Promotion policy (S

98-8) and the CFA Collective Bargaining Agreement; and

Whereas, Dr. Merdinger's leadership supported the Inclusive Excellence Master

Plan through developing training guidelines for diverse faculty hires, supporting outreach efforts to increase diversity in faculty hiring; and

Whereas, Dr. Merdinger has shown a commitment to faculty development and
