Executive Committee Minutes April 1, 2020 (Emergency Meeting) ADM 167, 11:00 a.m. to 1:00 p.m.

- 1. For the first part of this meeting we will act as a committee drafting a policy recommendation. The second part of the meeting we will convene and act as the Academic Senate.
- 2. Review and discussion of the draft policy recommendation, *Temporary Amendment to University Policies F18-5 and S16-16, University Grading and Probation and Disqualification Policies due to COVID-19.*
 - a. Committee discussed need for this recommendation, highlighting maximum flexibility for students.
 - b. Discussed implementation processes. SJSU registrar and Vice Provost, Undergraduate Education provided detailed information regarding roster process, grade change process, staffing resources.
 - c. AS president noted that dates were discussed with students.
 - d. Questions about what are the farthest dates possible to give flexibility, but still allow our graduating students the ability to graduate in a timely fashion.

Changes made to the draft recommendation based on committee discussion:

-Changed number 2 of the first Resolved clause to insert "normally" before "revert to a letter grade."

-Changed the date in number 2 of the first Resolved clause from "April 30, 2020" to "May 1, 2020."

-Changed the date in the 2nd line of line number 3 under the first Resolved clause from "June 15, 2020" to "June 8, 2020."

-Changed number 3 under the first Resolved clause to read, "A student can petition to the Registrar for a grade change from the time the grade is posted through June 8, 2020 to convert a letter grade to credit/no credit due to...".

-Changed to add, "posted" before "letter grade."

-Dropped the last sentence of the section, "Other implications:" that reads, "Students could also consider requesting an incomplete or an approved late withdrawal for courses for Spring 2020 semester in consultation with the instructor of record."

-Struck the sentence in lines 5 and 6 of the Rationale clause that reads, "For example, a shift to Credit/No Credit grading in a course means that the course cannot be calculated in a student's GPA."

-Added "academic" before "probation" in the 2nd line of the 2nd Resolved clause.

-Changed the first line of first Resolved clause number 3 that reads, "3. A student can petition the Registrar..." to read, "3. A student can petition to the Registrar...".

The Executive Committee voted to move this forward to vote as the Senate Executive Committee on the behalf of the Senate (13-0-0).

- 3. The Executive Committee convened acting for the Academic Senate.
- 4. Call to order and roll call by participant list on Zoom.
- 5. The Executive Committee discussed AS 1769, Policy Recommendation, Temporary Amendment to University Policies F18-5 and S16-16, University Grading and Probation and Disqualification Policies due to COVID-19 (Final Reading).
- 6. No amendments were suggested. The committee voted and AS 1769 passed (13-0-0).
- 7. The meeting adjourned at 1:11 p.m.
